## Vehicle Transport/Disposal Branch Site Addendum

(To register a branch site of a **Registered Tow Truck Operator** or **Motor Vehicle Wrecker**)

### Instructions for Completing This Form

- This form is only for businesses that are already licensed or have applied for a principal business location and are now registering an additional (branch) site related to that principal location.
- This addendum must accompany a Business License Application.
- Please print or type, using dark ink.

#### Registered tow truck operator branch site

1. Write "Tow Truck Branch Site" in Section 2 on the front page of the Business License Application form (there is no fee for this license).
2. Complete Section A on this form, identifying the principal business location to which the branch site relates **and** enter the physical address of the branch. This section must be completed before you contact local approving authorities.
3. Have the local zoning office and the Washington State Patrol complete their portions of Section B of this form.
4. Attach this form to the Business License Application and submit with the Business License Application fee.

#### Motor vehicle wrecker branch site

1. Write "Motor Vehicle Wrecker Branch Site" in Section 2 on the front page of the Business License Application form (there is no fee for this license).
2. Complete Section A on this form, identifying the principal business location to which the branch site relates **and** enter the physical address of the branch site. This section must be completed before you contact local approving authorities.
3. Complete Section C on this form, listing vehicles you will use at this site which are in addition to any wrecker vehicles you have already registered. Each vehicle listed will be issued a set of wrecker license plates. The fee for license plates is \$3 each.
4. Calculate the total amount due for wrecker license plates and write "Wrecker Plates" and the amount due, in section 2 , on the front page of the Business License Application.
5. Complete and attach the State Environmental Policy Act (SEPA) checklist for review by the local zoning office.
6. Have the local zoning office and the appropriate law enforcement official complete their portions of Section D of this addendum.
7. Attach this form and the SEPA checklist to the Business License Application and submit with the appropriate fees.
